2.00	The Texas Office of the Attorney General (OAG) continues to employ two ARRA-funded employees as of this quarterly reporting period, including an Assistant Attorney General (job category: Courts/Prosecution, Defense, and Civil Attorneys), and an Investigator (job category: Law Enforcement). The OAG Legal Assistant resigned from the agency and the ARRA-funded position as of February 22, 2012. On March 30, 2012, the OAG received written approval from the federal grant manager to create two part-time (20 hours each per week) Legal Assistant positions. The OAG has posted the job openings and is in the process of interviewing and selecting applicants for the two positions. Prime Recipient (2 FTE): 1 FTE Courts/Prosecution, Defense, and Civil Attorneys; 1 FTE Law Enforcement. As stated in the Quarterly Activities/Project Description, the ARRA grant-funded administrative assistant position with the Pasadena ISD Police Department has been eliminated effective March 31, 2012 (last official date on the grant was March 30, 2012).

Quarterly Activities/Project Description*

The Internet Crimes Against Children Task Force for the Southern Part of Texas, which includes the Houston metro region, will expand existing services within its geographic area of responsibility to assist in the enforcement of laws and prosecution of criminal offenses involving child pornography and the online solicitation of minors. The OAG will provide investigative and prosecutorial support to other law enforcement entities with whom the OAG has formalized partnerships, and the OAG will respond to CyberTipLine referrals. The subrecipient award to Pasadena ISD Police Department has been completed, and the ARRA grant-funded administrative assistant position has been eliminated effective March 31, 2012 (last official date on the grant was March 30, 2012).
