Dear Ms. Hale:

You ask whether certain information is subject to required public disclosure under chapter 552 of the Government Code. Your request was assigned ID# 372717 (PIR #09-26860).

The Office of the Attorney General (the "OAG") received a request for the crime victim's compensation claim file of the requestor's client. The OAG has released some information and asserts the remainder is excepted from disclosure under sections 552.101 and 552.108 of the Government Code. We have considered the OAG's claimed exceptions and have reviewed the information at issue.

Section 552.108(a)(1) excepts from disclosure information held by a law enforcement agency or prosecutor that deals with the detection, investigation, or prosecution of crime if release of the information would interfere with the detection, investigation, or prosecution of crime. Gov't Code § 552.108(a)(1). By its terms, section 552.108 applies only to a law enforcement agency or a prosecutor. This office has concluded, however, that where an incident involving alleged criminal conduct is still under active investigation or prosecution, section 552.108 may be invoked by any proper custodian of information that relates to the incident. *See* Open Records Decision Nos. 474 (1987), 372 (1983). Where a non-law enforcement agency is in the custody of information relating to the pending case of a law enforcement agency, the custodian of the records may withhold the information if it provides this office with a


demonstration that the information relates to the pending case and a representation from the law enforcement entity that it wishes to withhold the information.

The submitted information shows the OAG's Crime Victim Services Division received the information from the Texas Department of Criminal Justice's Office of the Inspector General (the "department") for purposes of processing the victim's claim file. *See* Crim. Proc. Code art. 56.38 (stating upon request, law enforcement entity must release all reports to OAG for purpose of determining crime victim's compensation claim). The OAG informed the department of the request, and the department asks the OAG to withhold the information from disclosure so as not to interfere with an ongoing criminal investigation. Attorney General Opinion MW-381 (1981); Open Records Decision No. 413 (1984) (concluding Texas Department of Corrections is law enforcement entity for purposes of section 552.108). Based on the submitted arguments and our review of the information, we agree release of the information will interfere with the detection, investigation, or prosecution of crime. *See Houston Chronicle Publ'g Co. v. City of Houston*, 531 S.W.2d 177 (Tex. Civ. App.—Houston [14th Dist.] 1975), *writ ref'd n.r.e. per curiam*, 536 S.W.2d 559 (Tex. 1976) (court delineates law enforcement interests that are present in active cases). Accordingly, the OAG may withhold the information the department seeks to withhold pursuant to section 552.108(a)(1) of the Government Code. Because section 552.108 is dispositive, we do not address the OAG's other argument.

This letter ruling is limited to the particular information at issue in this request and limited to the facts as presented to us; therefore, this ruling must not be relied upon as a previous determination regarding any other information or any other circumstances.

This ruling triggers important deadlines regarding the rights and responsibilities of the governmental body and of the requestor.
