Dear Mr. Tracy:

You ask whether certain information is subject to required public disclosure under the Public Information Act (the "Act"), chapter 552 of the Government Code. Your request was assigned ID# 393550.

The University of Houston (the "university") received a request for award and bid tabulation information pertaining to RFO # 730. Although you take no position with respect to the public availability of the submitted information, you state that the requests may implicate the proprietary interests of Ciber, Inc. ("Ciber"), Datatel, Inc. ("Datatel"), Deuce Creative, LLC, ePowered Schools, Mind Over Media, Nimble Services, Inc., PWL Studio, Stamats, Inc. ("Stamats"), SunNet Solutions Corp., and Toadfly Technologies. Accordingly, you notified these third parties of the request and of their right to submit arguments to this office as to why their information should not be released. *See* Gov't Code § 552.305(d) (permitting interested third party to submit to attorney general reasons why requested information should not be released); *see also* Open Records Decision No. 542 (1990) (determining that statutory predecessor to section 552.305 permits governmental body to rely on interested third party to raise and explain applicability of exception to disclosure in certain circumstances). We have received arguments from Ciber, Datatel, and Stamats. We have considered the submitted arguments and reviewed the submitted information.


Initially, we note Ciber, Datatel, and Stamats seek to withhold information the university has not submitted for our review. Because such information was not submitted by the governmental body, this ruling does not address that information and is limited to the information submitted as responsive by the university. *See* Gov't Code § 552.301(e)(1)(D) (governmental body requesting decision from Attorney General must submit copy of specific information requested).

Next, we note that an interested third party is allowed ten business days after the date of its receipt of the governmental body's notice under section 552.305(d) of the Government Code to submit its reasons, if any, as to why requested information relating to it should be withheld from disclosure. *See* Gov't Code § 552.305(d)(2)(B). As of the date of this letter, we have only received arguments from Ciber, Datatel, and Stamats. We, thus, have no basis for concluding that any portion of the submitted information constitutes the other companies' proprietary information. *See id.* § 552.110; Open Records Decision Nos. 661 at 5-6 (1999) (to prevent disclosure of commercial or financial information, party must show by specific factual evidence, not conclusory or generalized allegations, that release of requested information would cause that party substantial competitive harm), 552 at 5 (1990) (party must establish *prima facie* case that information is trade secret), 542 at 3. Accordingly, the university may not withhold any of the submitted information based on the proprietary interests of the non-briefing third parties. As no exceptions to disclosure have been raised for the submitted bid tabulation sheets, this information must be released to the requestor.

This letter ruling is limited to the particular information at issue in this request and limited to the facts as presented to us; therefore, this ruling must not be relied upon as a previous determination regarding any other information or any other circumstances.

This ruling triggers important deadlines regarding the rights and responsibilities of the governmental body and of the requestor.
