Dear Ms. Towe:

You ask whether certain information is subject to required public disclosure under the Public Information Act (the "Act"), chapter 552 of the Government Code. Your request was assigned ID# 440042.

The Texas Department of Criminal Justice (the "department") received a request for interview documentation for all applicants interviewed and any additional information pertaining to HRS III/Skyview Unit-Job Posting 00442SV. You state some of the requested information has been or will be released to the requestor. You claim the submitted information is excepted from disclosure pursuant to section 552.122 of the Government Code. We have considered the exception you claim and reviewed the submitted information.

Section 552.122 of the Government Code excepts from required public disclosure "a test item developed by a . . . governmental body[.]" Gov't Code § 552.122(b). In Open Records Decision No. 626 (1994), this office determined the term "test item" in section 552.122 includes "any standard means by which an individual's or group's knowledge or ability in a particular area is evaluated," but does not encompass evaluations of an employee's overall job performance or suitability. ORD 626 at 6. The question of whether specific information falls within the scope of section 552.122(b) must be determined on a case-by-case basis. *Id.* Traditionally, this office has applied section 552.122 where release of "test items" might compromise the effectiveness of future examinations. *Id.* at 4-5; *see also* Open Records Decision No. 118 (1976). Section 552.122 also protects the answers to test questions when the answers might reveal the questions themselves. *See* Attorney General Opinion JM-640 at 3 (1987); ORD 626 at 8.

You state the submitted interview questions are “intended to display the technical expertise of the applicant” and the department prefers to use similar questions from one position selection to the next. Further, you argue release of the information at issue could compromise future interviews. Having considered your arguments and reviewed the submitted information, we find interview questions 4, 8, and 9 qualify as test items under section 552.122(b) of the Government Code. We also find the release of the model and actual answers to these questions would tend to reveal the questions themselves. Therefore, the department may withhold interview questions 4, 8, and 9, along with the corresponding model and actual answers, pursuant to section 552.122(b). However, we conclude the remaining interview questions are general questions that evaluate an applicant’s individual abilities and personal opinions, and do not test any specific knowledge of an applicant. Accordingly, the remaining interview questions, as well as the corresponding model and actual answers, may not be withheld from disclosure under section 552.122. As you raise no further exceptions to disclosure, the remaining questions and their corresponding model and actual answers must be released.

This letter ruling is limited to the particular information at issue in this request and limited to the facts as presented to us; therefore, this ruling must not be relied upon as a previous determination regarding any other information or any other circumstances.

This ruling triggers important deadlines regarding the rights and responsibilities of the governmental body and of the requestor.
