Dear Mr. Giles:

You ask whether certain information is subject to required public disclosure under the Public Information Act (the "Act"), chapter 552 of the Government Code. Your request was assigned ID# 468472.

The City Public Service Board of the City of San Antonio d/b/a CPS Energy ("CPS") received a request for "a list of vendors, contractors, and/or subcontractors that are performing or have performed CAD drafting, scanning, plotting, and associated services for CPS" within a specified time period, as well as "the most recent unit price information for . . . contracts associated with these types of services." You state CPS has released the requested list to the requestor. Although CPS takes no position as to the public availability of the submitted information, you state release of this information may implicate the proprietary interests of third parties. Accordingly, you state, and provide documentation demonstrating, CPS notified Automotive Design Corp.; Flores Technical Services; Babcock & Wilcox Power Generation Group, Inc.; Schneider Engineering, Ltd.; and M&S Engineering, Ltd. of the request for information and of their right to submit arguments stating why their information should not be released. *See* Gov't Code § 552.305 (permitting interested third party to submit to attorney general reasons why requested information should not be released); Open Records Decision No. 542 (1990) (determining statutory predecessor to section 552.305 permits governmental body to rely on interested third party to raise and explain applicability of exception in certain circumstances). We have reviewed the submitted information.

An interested third party is allowed ten business days after the date of its receipt of the governmental body's notice under section 552.305(d) to submit its reasons, if any, as to why requested information relating to it should be withheld from disclosure. *See* Gov't Code § 552.305(d)(2)(B). As of the date of this letter, this office has not received comments from any of the third parties explaining why their information should not be released to the requestor. Thus, we have no basis to conclude that the release of any portion of the requested information would implicate any of the third parties' interests. *See id.* § 552.110; Open Records Decision Nos. 661 at 5-6 (1999) (to prevent disclosure of commercial or financial information, party must show by specific factual evidence, not conclusory or generalized allegations, that release of requested information would cause that party substantial competitive harm), 552 at 5 (1990) (party must establish *prima facie* case that information is trade secret), 542 at 3. Accordingly, we conclude that CPS may not withhold any of the submitted information on the basis of any interest a third party may have in the information. As no exceptions to disclosure have been raised, CPS must release the submitted information.

This letter ruling is limited to the particular information at issue in this request and limited to the facts as presented to us; therefore, this ruling must not be relied upon as a previous determination regarding any other information or any other circumstances.

This ruling triggers important deadlines regarding the rights and responsibilities of the governmental body and of the requestor.
