Dear Mr. Galindo:

You ask whether certain information is subject to required public disclosure under chapter 552 of the Government Code. Your request was assigned ID# 495216 (PIR No. 13-36281).

The Office of the Attorney General (the "OAG") received a request for information pertaining to the "investigation and prosecution of the Archer County Judge, . . . for official misconduct, misapplication of fiduciary property, etc." The OAG asserts the information is excepted from disclosure under sections 552.101, 552.107, and 552.108 of the Government Code. We have considered the OAG's claimed exceptions to disclosure and have reviewed the submitted sample of information.<sup>1</sup>

Section 552.108(a)(2) of the Government Code excepts from disclosure information concerning an investigation that concluded in a result other than conviction or deferred adjudication. Gov't Code § 552.108(a)(2). A governmental body claiming section 552.108(a)(2) must demonstrate the requested information relates to a criminal investigation



that has concluded in a final result other than a conviction or deferred adjudication. The OAG explains Exhibit B pertains to a case investigated by its Law Enforcement and Criminal Prosecutions Divisions that concluded and did not result in conviction or deferred adjudication. Thus, the OAG may withhold Exhibit B from disclosure based on section 552.108(a)(2). Because section 552.108(a)(2) is dispositive, we do not address the OAG's other assertions.

This letter ruling is limited to the particular information at issue in this request and limited to the facts as presented to us; therefore, this ruling must not be relied upon as a previous determination regarding any other information or any other circumstances.

This ruling triggers important deadlines regarding the rights and responsibilities of the governmental body and of the requestor.
