OPEN RECORDS REQUEST OF GREG JOSLYN DATED 3-4-91

Dear Sir or Madam:

Attached is the Open Records Act Request of Greg Joslyn received by this office on March 4, 1991. He is requesting documents pertaining to the City's involvement with Mayor Day, Caldwell & Keeton, a Houston law firm, since December 5, 1990. The City of League City had been using Mayor, Day, Caldwell & Keeton as its City Attorney until January 31, 1991. Since then the City has been using Mayor, Day, Caldwell & Keeton as outside counsel. The representation involved legal advice on resolutions, ordinances, litigation, and economic projects. Such documentation would apparently be exempt from disclosure under 6.02(a)(7) of Article 6102-17a.

Pursuant to Article 6102-17a, 6.07(a), the City of League City is requesting a decision from your office whether the information requested by Mr. Joslyn is within the exception as noted in 6.02(a)(7) of Article 6102-17a.
