Pursuant to the authority of Article 6252-17a, this is to request your opinion as to whether certain material requested by inmate David C. Johnson, TDCJ-ID #295880 is excepted from release to him.

Mr. Johnson has requested an opportunity to review the Beto II unit personnel files of four officers assigned to that unit. We believe that parts of the requested records may be excepted from release pursuant to the provisions of Article 6252-17a, section 3(a)(1), confidential information, and section 3(a)(2), intrusive information in personnel files. We are collecting the records, reviewing them and will provide you with a more detailed evaluation as to those portions we believe to be excepted in the near future.
