

I am pleased to present the inaugural Landowner Compensation Program (LCP) Annual Report. The increasing impact of border crime has led to significant damage for agricultural landowners across Texas. In response, the Legislature established the LCP to directly address this issue, tasking the Office of the Attorney General with building and administering the program. The bill creating the LCP went into effect on September 1, 2023.

In just eight months, our office has successfully developed and launched the LCP by establishing administrative rules, designing program policies and procedures, creating an online application portal and management system, hiring and training dedicated staff, and launching the program's webpage and marketing materials.

Our outreach to promote the LCP has included partnerships with law enforcement agencies and county officials, along with attendance at four outreach events in FY2024, where staff engaged with over 1,000 participants.

Within the first four months of the fiscal year, the LCP received 45 applications, with 9 claims approved for compensation. These awards totaled \$25,003.62, providing critical support to landowners whose agricultural property sustained real damage.

We are excited to watch this program expand as more landowners become aware of this resource and receive the support they need to restore their land.

PROGRAM ELIGIBILITY

To be eligible, the claimant must be the owner of agricultural land or an authorized agent. They can apply either as an individual or as a business, depending on how the property is owned. If an authorized agent applies, they must provide proof of authorization.

Lessees (those leasing the land) are not eligible but can submit an application on behalf of the landowner if authorized, with any payments going to the landowner.

The claimant or agent must provide proof of ownership, usually through the county appraisal district (CAD) property ID or AG/Timber number. If ownership can't be verified, the property deed must be provided.

Agricultural Land

The claimant must prove that the property is agricultural land by providing the associated CAD property ID or AG/Timber registration number. The AG/Timber number is issued by the Texas Comptroller when agricultural land qualifies for a tax exemption based on its use.

Real Property Damage

Eligible real property includes, but is not limited to:

- Fences;
- Houses;
- Transportable structures designed for residential or business purposes (provided the owner also owns the land);
- Barns; or
- Silos.

Ineligible property includes:

- Recreational vehicles;
- Oil and gas production equipment not owned by the landowner;
- Crops, farm equipment, or livestock.

Crimes Involving Border Trespass

To be eligible for compensation, the real property damage must have been caused by a trespasser in connection with a border crime or during a law enforcement response to such a trespasser.

Date of Crime

The crime must have occurred after August 31, 2023.

Trespass

The trespass must result from one of the following offenses under Tex. Pen. Code, Ch. 28:

- Arson;
- Criminal Mischief;
- Reckless Damage or Destruction;
- Graffiti.

Border Crime

The trespass must involve transnational criminal activity and at least one of the following offenses:

- Controlled substance violations (Tex. Health & Safety Code 481, Subchapter D);
- Smuggling of persons (Tex. Pen. Code \$20.05);
- Evading arrest or detention (Tex. Pen. Code §38.04);
- Trafficking of persons (Tex. Pen. Code, Ch. 20A).

Report to Law Enforcement

The real property damage must be documented in a report from a law enforcement agency (LEA).

The LEA report must include:

- A description of the property damage;
- The agricultural land where the damage occurred (the address must match the application);
- Confirmation that the damage was caused by a trespasser involved in an offense under Ch. 28, Penal Code, or law enforcement response to such a trespasser;
- Indication that the trespass was in furtherance of a border crime, including the applicable offense.

In rural areas, the law enforcement report may include GPS coordinates.

Timely Filing and Reporting

Applications must be submitted within 90 days of the incident unless good cause is demonstrated for a delay.

Applications should be reported to law enforcement within a reasonable timeframe. Generally, reporting within 72 hours is considered reasonable. If the report is delayed to the point that it hampers the investigation or prosecution, the application may be deemed ineligible unless good cause is shown for the delay.





The OAG attended **FOUR OUTREACH EVENTS** reaching **1,000 TOTAL PARTICIPANTS**












