**Texas Office of the Attorney General Names State Office Child Support Employee
Assistant Attorney General of the Year**
Ashley Philip singled out as region's top attorney for dedication to Texas children

Dallas – The Office of the Attorney General recognized Ashley Philip, an Assistant Attorney General (“AAG”) in the Child Support Division’s Dallas office, for her commitment to Texas children. Philip was named Assistant Attorney General of the Year for the Child Support Division’s Region 4. She was presented with the award on Tuesday, July 30, 2024, at the Statewide Assistant Attorneys General Conference.

“I commend Ashley for her exceptional dedication to Texas children and families,” Attorney General Paxton said. “Her exemplary service and unwavering commitment embodies the highest of standards. We are profoundly grateful for her contributions and her steadfast loyalty to the people of Texas.”

One Assistant Attorney General was selected for this honor from each of the state’s ten child support regions, along with an Assistant Attorney General from the Child Support Division headquarters office in Austin. Honorees are chosen based on recommendations from their peers and supervisors, focusing on employees willing to go beyond their normal duties to serve Texas children. Each recipient demonstrates a desire to serve Texas families, help their colleagues, and enhance the Attorney General’s Child Support Division.

Philip, who joined the Office of the Attorney General in 2016, represents the State of Texas in legal actions to establish paternity between children of unmarried parents and their biological fathers. She also works to establish, enforce, and modify court orders that require parents to provide child support, medical support, and dental support.

A graduate of the Texas Tech University School of Law, Philip was chosen to be the region’s Assistant Attorney General of the Year for being an exemplary attorney, a willing trainer, and a strong leader. She has demonstrated the willingness to take on any task and provide wise legal direction to her co-workers, earning the reputation as a reliable leader.
